### **Categories of Recognition**

The following categories of recognition are:

#### **Cable Detailing**

Nominated person is familiar with design and construction of electrical underground systems and is competent to undertake recording of "as constructed" underground assets on site. Assets are to be detailed in such a manner so that they can be re-established using basic survey techniques (i.e. Pedometer, Tape measure, Range Poles) from permanent reference points, e.g. Side entry/storm water pits, building lines and lot boundaries. #### **Cable Plan Updating)**

Nominated person is an experienced draftsman that has electrical industry experience and is familiar with design and construction of electrical underground systems. The draftsman is competent to create/update underground cable plans to Powercor/CitiPower Electricity Network Drafting Standards DD230 series.
